Treasurer's Report – Lisa Sutliff

- 23 homeowners now have liens on their properties for unpaid dues.

Maintenance Committee Report – Russell Quesenberry

- Board approved by email on July 28 to pay Grooms Irrigation & Landscape \$3,533.03 for purchase and installation of plants at the Pennsylvania entrance median. Install will start the second or third week of September.
- Board approved by email on July 19-23 to pay \$4,300 to Design Build Masonry for the single brick panel. An amount of \$3,800 was approved prior to installation, however, following demolition a second column was required replacement.
- Quesenberry made a motion to spend the \$2,933.65, to replace five sprinkler control panels, which include rain/freeze sensors. Nokes seconded. Motion passed 8-0.
